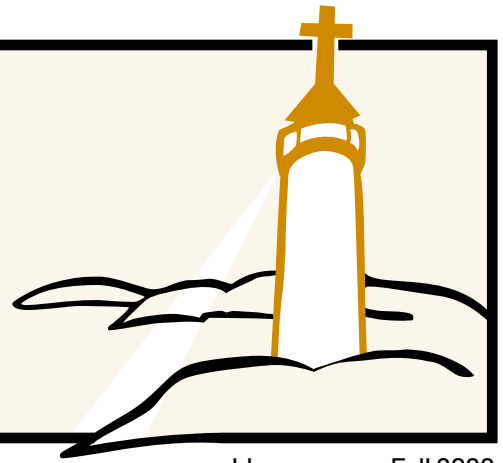

Bethel Lutheran Foundation Office Relocates

We will be relocating our Foundation office from its current location in Bethel's Arbor House to Golden Estates located at 56 22nd Street West, #3.

Our current location is in an unfinished 2-bedroom unit located in Bethel Arbor House Assisted Living. The move will allow the unit to be finished and available for future Assisted

Living tenants. The perception has often been since Bethel Foundation office is located within the Arbor House, that the Foundation owns and manages this property. By locating our office to one of the Foundation properties, it will allow Bethel to increase its census at the Arbor House and better serve our community. Golden Estates has ample parking available and is conveniently located.

Your Support IS NEEDED

There are many ways to support the Mission of Bethel, please consult your tax advisor or call the Bethel Foundation office at 701.572.0223.

Bethel depends on our church sponsors and community. We are very appreciative of your financial gifts that improve the lives of the residents we serve. Resident rates are set/limited by North Dakota's rate equalization reimbursement system. North Dakota Medicaid and Medicare rates typically (hopefully) cover the cost of providing direct care to our residents. However, our Foundation is looked upon to help support facility improvements and other quality of life services. Please consider one of the following ways you could make a positive difference in the quality of care Bethel provides.

GIFTS OF CASH: The easiest way to obtain a charitable deduction is to support Bethel through a cash gift. If you itemize, your gift may be fully deductible.

BEQUEST/WILL: Consider naming Bethel in your will for any fixed or proportionate share of your estate.

GIFTS OF APPRECIATED STOCKS/BONDS: Giving long-term appreciated stocks or bonds avoids capital gains tax and you

will receive an immediate tax deduction based on the full fair market value on the date of the transfer.

GIFTS OF LIFE INSURANCE: Designating Bethel Lutheran Foundation as the owner and beneficiary of an existing or new insurance policy usually offers a tax advantage in the year the gift was made. If the policy is paid up, the charitable deduction will be the cash value at the time of the gift. If the policy is not paid up, you continue to pay annual premiums which will become tax deductible for you each year.

GIFTS OF REAL ESTATE: If you have owned rental property, farmland or other real estate for many years, a charitable gift of that property can be especially tax advantageous. If sold outright, the sale could result in capital gains on any appreciation, and ordinary income on any depreciation recaptured. A charitable gift to Bethel may avoid the tax consequence and realize a charitable deduction for the full market value of the real estate.

Foundation *Corner*

Bethel Lutheran Nursing & Rehabilitation Center and Bethel Lutheran Foundation held their respective annual meetings on September 28 at the Williston ARC. These meetings allow organizations to review previous year's events, review audited financials, address future plans, and elect and recognize Board members.

I would like to thank Grant Carns for serving on our Foundation Board for the past three years. I would also like to acknowledge Paula Jarland for her many years of service on Bethel's Board and an additional six years on our Foundation Board. Aaron Schmit will be joining the Foundation Board following his service on the Bethel Board; and Tina Hansen will be one of Bethel's representatives on the Foundation Board, along with Peggy Sundet. Stuart Langager currently serves as our Chairperson and Ken Kjos is another dedicated Board member.

Bethel and the City of Williston should be able to finalize the purchase of approximately 18 acres of land in the Williston Square development before year-end. There is still a lot of time, effort and support that will be needed before a new Bethel becomes a reality.

Our Building Committee and Bethel's administrative team recently met with EAPC architectural representatives to provide an update on the land purchase and begin the visioning process of what a new Bethel would look like, the services provided and the space allocation of the new facility.

Over the course of the last several years, construction costs have risen dramatically. The overall size of a new facility is controlled by the State of North Dakota on a square footage (950) per licensed bed. For example if a 100 bed facility would be built (Bethel currently has a census of 91 skilled care residents) the square footage of the entire facility could be 95,000 square feet (100 x 950). With cost estimates ranging from \$400 - \$500 per square foot, the facility would be estimated to cost up to \$47.6 million. In order to stay within the limits of the Department of Human Services reimbursement system, the maximum that could be financed would be approximately \$35 million. To make this facility a reality, Bethel will need to fund the remaining \$12.5 million through gifts and capital reserves.

Bethel is fortunate that our existing facility is debt-free. When a new facility is built, the exiting property can hopefully be sold and the land developed. The more funds that Bethel can raise for this project, the less we will have to borrow. Less debt translates to less interest paid on borrowed funds and this translates to reduced rates for our future residents.

Our city has grown and the quality of life has been enhanced for many through the construction of the ARC, and the future plans for a new outdoor pool and proposed new sports complex to support hockey. These are all worthy projects that deserve support; however, the measure of a community is how it enhances the quality of life for all of its residents....young to old. As our community ages, we must also plan and support services that will improve the quality of life for those that are in their golden years.

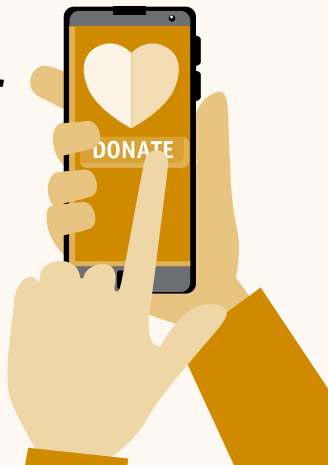

NUTRITION TIP

Apple Cinnamon Baked Oatmeal



INGREDIENTS

- 1½ cups fat-free milk or soy milk
- ½ cup packed brown sugar
- ½ cup egg substitute or egg whites
- 1 tbsp melted trans-fat-free margarine
- ½ tsp cinnamon
- 2 cups rolled oats (not instant)
- 1 tsp baking powder
- 1½ cups chopped apples

DIRECTIONS

1. Preheat oven to 350°F.
2. In a small bowl mix the milk, brown sugar, egg substitute/whites, margarine and cinnamon.
3. In a larger bowl combine the oats and the baking powder.
4. Pour the wet mixture into the bowl with the oats; add the apples and stir to combine.
5. Spoon the mixture into a 8-by-8-inch pan coated with cooking spray and bake for 30 to 40 minutes, until top is firm and a toothpick comes out clean in the center.

Most of us know someone who has been impacted by Alzheimer's disease, whether it's touched our own family or a friend's loved ones.

Dementia | AND THE ROLE OF OCCUPATIONAL THERAPY

Dementia results from impaired cognition, due to damage to the brain. The signs of dementia generally include, but are not limited to, decreased short-term memory, decreased problem-solving skills, and decreased perceptual skills, problems with communication and language, and personality changes. The onset of dementia is gradual, and the course of the disease spans several years or more. In Alzheimer's disease, the person progresses through several stages that roughly coincide with reverse developmental levels, with those in the final stages being completely dependent on others.

Occupational therapists evaluate persons with dementia to determine their strengths, impairments, and performance areas needing intervention. Although remediation of cognitive performance is unlikely, the person may demonstrate improved function through compensation or adaptation. Occupational therapy practitioners also assist care providers with coping with this difficult, and yet often rewarding, role.

The following are common problematic behaviors among people with Alzheimer's disease, and potential occupational therapy and team intervention:

Person forgets what season it is when selecting clothing: Help the care provider set up limited clothing selections to fit the season, which helps avoid conflict while supporting client choice and self-efficacy.

Person gets disoriented and wanders: Set up the environment to enhance daily activity, including mobility within safe confines, and use technology to ensure safety. Sometimes a fenced courtyard with stop signs at the gates could be all that is needed to keep the person oriented to his or her own yard; for others, alarms can be installed to go off when the person opens a gate or a door.

Person has trouble communicating, along with uncharacteristic, frequent outbursts: Help caregivers identify nonverbal cues. Teach the concepts of caring, non-defensive responding techniques, and work on determining the underlying emotion that may have precipitated the client's behavioral outbursts. Avoid correcting factual errors.

Person paces or shows other repetitive non-productive behavior: Occupational tasks that fulfill the person's need to be productive and help support relationships with others. For example, if the person once enjoyed crossword puzzles, perhaps simplified puzzles or word searches would still be enjoyable. Simple, repetitive tasks like folding laundry can lead to feelings of accomplishment.

In the early stages of dementia, when the person is having difficulty with higher-level executive skills, he or she may be referred to occupational therapy for evaluation and intervention to address driving, work, and safety. In the middle stages, home safety and staying engaged in personally meaningful tasks become the paramount focus. During the late stages, when the person may be having difficulty with basic ADLs (e.g., feeding, toileting, mobility) the focus may switch to decreasing caregiver burden and enhancing basic care (e.g., safe transfers, skin protection, avoiding contractures, enjoyable sensory stimulation).

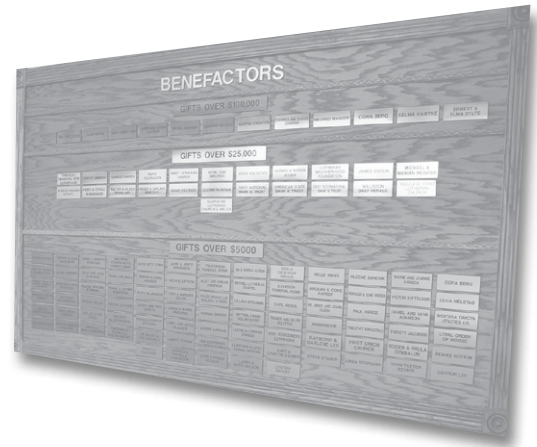

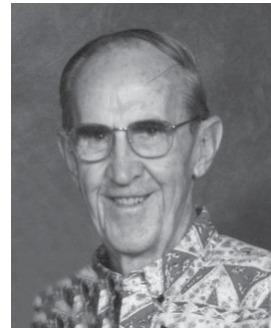
