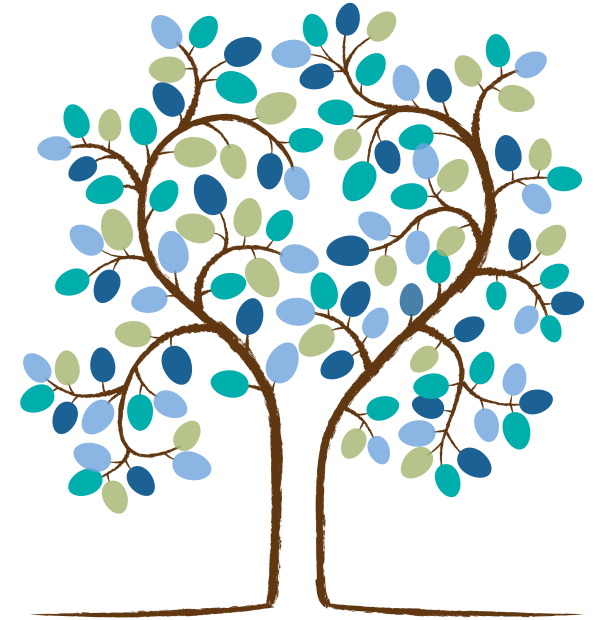

ABOUT SIDNEY HEALTH CENTER

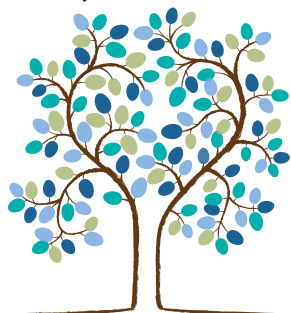
